## 1. The subject of the contract

1.1 Rocketman s.r.o. (called the “**Company**” or “**DEVS**” in this document) enables leasing of electric motorcycles through its operation advertised on the website [www.devs.bike](http://www.devs.bike).

## 2. Price, charges and conditions of leasing of motorcycle(s)

2.2 Renters must familiarise themselves with all the terms and conditions as they form your legal agreement with the Company. By signing this contract, the Renter is accepting the prices, charges and terms of the GTC.

2.3 The Company has the right to change the GTC at any time, which the Renter accepts.



### 3. Duration of the contract

3.1 This contract becomes valid and effective on the day of crediting the payment of the initial fee in full to the Company's bank account, or on the day of its payment to the Company in cash and is concluded for an indefinite period.

3.2 This contract can be unilaterally terminated by either party according to § 6 of the GTC.

3.3 The Renter as a consumer is entitled to withdraw from the contract within 14 days of its conclusion.

### 4. Declaration and instructions of the Renter

4.1 Upon conclusion of this contract, all previous agreements of the contracting parties relating to the subject matter of this contract made both verbally and in writing, become invalid.

4.2 This contract can only be changed in the form of written amendments signed by both parties.

4.3 The contracting parties have properly read the text of this contract, they are aware of the individual rights and obligations resulting from this contract, and they do not find any ambiguities in the provisions of this contract.

4.4 This contract is a reflection of the true and free will of the contracting parties free from error. The contracting parties sign it as a sign of their agreement with the rights and obligations arising from it, as an integral whole, on the day, month and year indicated below.
